Information clause in connection with the notification of a breach

In connection with your application, the Controller processes your data in the following scope: name and surname, e-mail address, correspondence address, contact telephone number.

The controller of your personal data is Merkson sp. z o.o. with its registered office in Starachowice (27-200) at 35A Składowa Street, hereinafter referred to as the "Controller". The Controller has not appointed a Data Protection Officer. The Controller of your data can be contacted at the following e-mail address: ochronadanych@merkson.pl

Rules for the processing of personal data.

Personal data will be processed for purposes related to reported cases of violation of the law, on the basis of:

- ❖ compliance with legal obligation resulting from the provisions of EU Directive 2019/1937 of 21.10.2019 and (in accordance with Article 6(c) of the GDPR);
- ❖ or the legitimate interests pursued by the controller, which is receiving, verifying and clarifying reports of violations of the law (in accordance with Article 6(1)(f) of the GDPR);
- ❖ or voluntary consent, if you do not choose to remain anonymous (in accordance with Article 6(1)(a) of the GDPR).

We ensure the confidentiality of your data in connection with the breach reporting process. The data will be made available only to entities authorized to do so under the law or postal operators to the extent necessary to clarify the notification.

Your personal data will be processed for a period of 5 years from the end of the case.

1. Every data subject shall have the right:

- a) **of access** (Article 15 of the GDPR);
- b) **to obtain a copy** (Article 15(3) of the GDPR);
- c) **to rectification** - (Article 16 of the GDPR);
to erasure of the data within the limits permitted by law (Article 17 of the GDPR);
- d) **to restriction of processing** (Article 18 of the GDPR) when:
 - ❖ the accuracy of the personal data is contested by the data subject, for a period enabling the controller to verify the accuracy of the personal data;
 - ❖ the processing is unlawful and the data subject opposes the erasure of the personal data and requests the restriction of their use instead;
 - ❖ the Controller no longer needs the personal data, but they are required by the data subject for the establishment, exercise or defence of legal claims;
 - ❖ the data subject has objected to the processing pending the verification whether the legitimate grounds of the controller override those of the data subject;
- e) **to data portability** - (Article 20 of the GDPR);
- f) **to object** - (Article 21 of the GDPR).

If you want to exercise the above mentioned rights, it is enough to contact the Controller, using the contact details provided above, and inform him/her which right and to what extent you want to exercise.

Your data will not be made available to a third country or an international organization, nor will it be subject to profiling or automated decision-making. In accordance with the Whistleblower

Protection Act, providing data is voluntary.

The data subject has the right to lodge a complaint with the supervisory authority, which in Poland is the President of the Office for Personal Data Protection with its registered office in Warsaw,
